

Yoga for Cancer Teacher Training Course Terms & Conditions

ELIGIBILITY

The Yoga for Cancer Teacher Training Course is an accredited 60-Hr Further Training with Yoga Alliance Professionals. To be eligible to attend, you need to be already qualified as a yoga teacher with at least 200-hrs teacher training or equivalent completed. You do not have to be currently teaching to be eligible for the course.

BOOKING

Once your application to the course is successful, you will need to book your place by either signing up to one of my instalment plans or making payment in full. If you sign up to an instalment plan, payment will be taken automatically on a monthly basis until complete.

Your place will only be confirmed once full payment of the first instalment has been received. Please note that your certificate will not be issued upon completion of the course until full payment has been made.

CANCELLATION POLICY

Once you have signed up to the Yoga for Cancer Teacher Training you will be liable for the full agreed fee. If you decide to cancel; there will be no refunds or transfers unless:

- the training is fully booked and your place can be filled from a waiting list, or
- you have valid medical reasons and can provide a doctor's note

In these cases, we will refund the fee. All clients are asked to agree to the terms and conditions upon booking a course or workshop.

If a course or workshop is cancelled, you will be offered either a cash refund or the option of being transferred to an alternative event.

If you decide to withdraw from the course part way through there will be no refund available.

ATTENDANCE POLICY

80% live attendance is required to obtain certification. All recordings of all the live zoom sessions will be available via the online learning portal so you can watch any that you miss. You will need to show that you watched the recorded sessions if you are unable to attend in person. You will also need to complete all the assignments by the stated deadline at the end of the course.

Recordings of all online sessions

Please note that all group sessions will be recorded and shared with the whole group. These recordings will not be available to anybody outside of the participant group apart from Yoga Alliance Professionals (YAP) if requested for quality monitoring purposes.

COURSE CONTENT

All trainings, assessments and mentoring sessions on the training courses are taken with Jenni Stone, a registered BWY teacher, Yoga Alliance Professionals Senior Yoga Teacher and TrainerPro. On occasion there may also be guest tutors offering additional content.

This training is fully delivered online via Zoom meetings and therefore you will need reliable access to internet and a suitable device to be able to take part. Please advise your tutor if you have special needs regarding your learning or ability to participate.

The videos of this course and all content of the online portal belong to Yoga for Cancer Academy and compile to copyright law and are protected legally. No content can be passed to third parties without prior written consent of Yoga for Cancer Academy.

No recordings either photographic, video or audio of live sessions may be made on other devices unless you have express permission in writing from Yoga for Cancer Academy.
